PRIVACY STATEMENT

This Privacy Statement describes the information that Cavendish Homes Inc (“the Company” “we” or ‘us”) collects about users to our website (“Site”) and how we use that information.

This Privacy Statement does not apply to websites, applications or services that display or link to a third-party Privacy Statement. We are not responsible for the privacy practices of other companies. Please read their privacy statement as they will apply to the personal information you provide on those websites.

At Cavendish Homes, we respect our customer’s privacy. Please read this statement carefully before providing any personal information to us. We reserve the right to modify the privacy statement from time to time so please review it frequently, by visiting the “Site” you will be deemed to accept and agree with the most recent privacy statement posted on the “ Site.”

We use this Privacy Statement to disclose the privacy practices of the “Company” in accordance with the provisions of Canada’s Personal Information Protection and Electronic Documents Act (“PIPEDA”) which governs the collection, use and disclosure of personal information during the course of a commercial activity.

Section 1 - Information We Collect

We may collect the following information about you on the “Site:”

Name, phone number, email address, and any information you may provide through your use of the “Site” or the “Company” email addresses that may be posted on the “Site” from time to time.

Non-identifying information about your visit to the “Site,” the pages you click on, and general Internet usage (including cookies)

Section 2 - Purposes of Collection, Use and Disclosure

The purpose(s) that you are providing personal information to us, such as when you voluntarily provide your email address through our “Contact Us” page You may choose not to provide the information but note that your use of the “Site “may consequently be limited. Please do not provide any information that is sensitive, confidential, or that you are not legally permitted to disclose to us.

We collect non-identifying information for purposes of improving the “Site” and analyzing online traffic and usage statistics.

Section 3 – Consent

How do you get my consent?

When you provide us with personal information by completing a request for information, we imply that you consent to our collecting it and using it for that specific reason only. We will collect, use and disclose your personal information only with your knowledge and consent when you provide an email address for us to respond to your inquiry.

If we ask for your personal information for a secondary reason, like marketing, we will either ask you directly for your expressed consent, or provide you with an opportunity to say no.

How do I withdraw my consent?

Section 4 - Accuracy of Personal Information

If you need to change or correct any personal information provided to us or wish to have all personal information we have collected removed from our files, please contact us and we will take reasonable steps to comply with your request.

Section 5 - Security

To protect your personal information, the 'Company' takes reasonable precautions and follows industry best practices to prevent unauthorised access to and improper use of your personal information.

The "Company" does not sell or disclose personal information to unaffiliated third parties, except that we may share personal information with third parties that are providing services to us, such as IT or website maintenance.

Section 6 - Cookies

When viewing the "Site," information in the form of a "cookie" or similar file may be stored on your computer or other device that you use to access the "Site." This information helps us tailor the "Site" in a manner to better match your interests and preferences. If you do not wish to receive cookies or want to be notified when they are placed on your device, many Internet browsers allow you to erase existing cookies, block cookies or warn you before a cookie is stored on your device.
